NON CASH CONTRIBUTIONS Deduction of less than \$250 - A receipt or a written acknowledgement from the charity.
Deduction between \$250 and \$500 - A written acknowledgement by the charitable organization. Deduction between \$501 and \$5,000 - Same records required as the \$250 to \$500 category. In addition, records must show how the property was acquired, the date acquired and the adjusted basis of the property. Deduction of more than \$5,000 - Same records required as the \$501 to \$5,000 ...

The amount you can deduct for charitable contributions generally is limited to no more than 60% of your adjusted gross income (AGI). Your deduction may be further limited to 50%, 30%, or 20% of your AGI, depending on the type of property you give and the type of organization you give it to.

Moreover, because of past valuation abuses by taxpayers, the IRS has imposed special rules for valuing some types of property. Other than cash contributions of up to \$300, you can only deduct charitable contributions if you itemize your personal deductions instead of taking the standard deduction.
